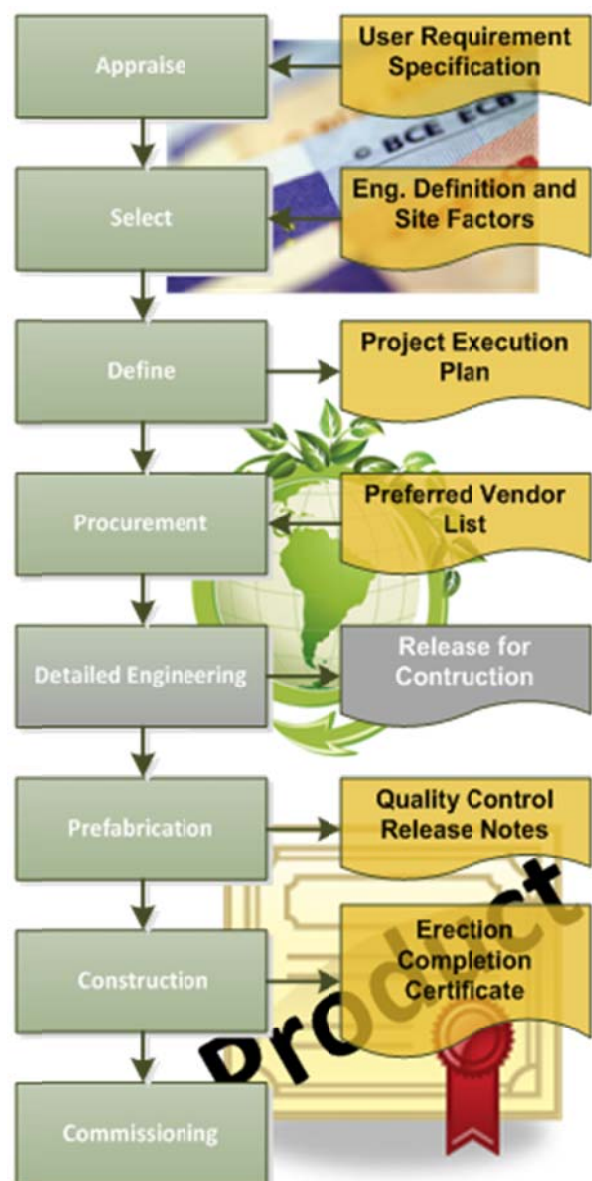
Joint Ventures
